# Curriculum and study structure

## SECOND YEAR OF STUDY

In the second year of studies, you can choose subjects in the field of tax and financial consulting to gain specialist preparation in this field. In semester III, you should choose two of the three subjects conducted in the form of lectures and exercises, and two of the three subjects in the form of seminars. In semester IV – three out of four subjects should be chosen in the form of seminars.

Starting from the third semester, students also participate in the diploma seminar, during which they prepare their master's thesis under the supervision of the supervisor. The diploma examination with the defence of the master's thesis completes the studies and allows you to obtain the professional title of master's degree.

## Tuition fees

### FIXED TUITION - FLEXIBLE PAYMENTS

By choosing to study at UEHS, you can be sure that the tuition fee will not change throughout the duration of your studies. You can pay the tuition fee once for the entire year of study or spread over a semester payment. This allows you to decide how you want to plan your expenses.

### REDUCE THE COST OF YOUR STUDIES

As part of the UEHS discount programme, you can take advantage of various reductions and promotions. They are usually applied in the first year of study. It means that your tuition fees will be reduced by the amount of the discounts granted. Candidates who register and pay their tuition fees within one month of registration will receive an English language course for free. The course covers 80 hours of English classes and 20 hours of classes of Polish culture.
